Note: The Beatrice Retirement Income Plan (May 1st 1941 to June 30th 1989) [John Hancock Mutual Life Insurance Company Annuity Contract No. 76]. Assets were held by two financial institutions. A trust fund under a trust agreement with The First National Bank of Chicago (now Chase Bank), and John Hancock Mutual Life Insurance Company. After June 30th 1989, Annuity Contract No. 76 was discontinued, and any remaining participants on that plan were continued to be covered by John Hancock Mutual Life Insurance Company. If you were vested in the plan prior to June 30th 1989, and did not retain any documentation on your benefits, please contact Beatrice Services, Inc. HR Operations. In certain instances, as for example with Beatrice Dairy Products, Inc. employees, the portion of BRIP was transferred to Borden, Inc. Retirement Income Plan, and the same may pertain to your particular former Beatrice division. If you are not sure you were a participant of this plan, contact Beatrice for assistance.

There are also instances where your retirement plan from another Beatrice subsidiary that was sold prior to ConAgra taking ownership may still be administered by ConAgra. Contact the current owner of the former Beatrice subsidiary and see if you are in their retirement account system.

The following will help with inquiries regarding policies originally issued by The Mutual Life Insurance Company (“Mutual Benefit”)

Mutual Benefit was placed in rehabilitation under the supervision of the New Jersey Department of Banking and Insurance on July 16, 1991. Mutual Benefits in-force policies were transferred to MBL Life Assurance Corporation (“MBL Life”), effective May 1, 1994. Mutual Benefit was ultimately liquidated and dissolved, effective June 14, 2001.

Subsequent to 1994, all former Mutual Benefit policies were administered by MBL Life pursuant to a Plan of Rehabilitation approved by the Superior Court of New Jersey (the “Court”). In 1998, MBL Life entered in to various transactions under which policy liabilities were transferred to other insurers. Each transaction was duly approved by the Court and filed with governing State Insurance Departments. Ultimately, an Order For Liquidation of MBL Life was entered, effective January, 2000. An Order For Dissolution was ordered by the court on October 22, 2004.

If the policy referenced in the inquiry was in force at the time of the applicable 1998 transaction, it was automatically transferred to one of the following insurers (depending on the type of policy):
